The Coast Grimshaw Hotel & Suites is a 63 room all-suite hotel. Property amenities include a swimming pool, waterslide, fitness center, meeting space and a breakfast room which serves a complimentary hot continental breakfast. The hotel is ideally located in Grimshaw at the junction of Highway 2 and Highway 2A which is referred to as Mile Zero of the Mackenzie Highway, known as the starting point, that takes you to the Northwest Territories. Guests of the property will enjoy a comfortable stay, as well as easy access to key Grimshaw attractions and amenities - within a couple of blocks.
